Solar Screen & Film Rebate Application

ELIGIBILITY:

1. Applications are subject to verification. The rebate will not be paid if the verification cannot be completed.
2. The installation address must match the address on the active BPUB residential electric services account.
3. The applications and supporting documents must be completed and submitted within 45 days of installation.
4. The rebate recipient (tenant/property owner) must be a BPUB customer. Property ownership will be verified using county tax records.
5. Only one application is accepted per address per fiscal year (October 1 through September 30).
6. BPUB may discontinue the program at any time. Rebates are contingent upon fund availability.

PROGRAM TERMS AND CONDITIONS:

1. Only window screens installed in a conditioned space will qualify.
2. Solar screens and films must block at least 65% of the Solar Heat Gain (SHG).
3. \$1.00 per square foot installed; up to \$500.00.
4. ENERGY STAR New Homes do not qualify.
5. Pictures of the window with solar screens/film after installation will be required.
6. A contractor's installation receipt, itemizing the total area of equipment installed, product identifiers, performance rating specifications, and data on the reflectivity of the window tint will be required.

PROGRAM INSTRUCTIONS:

You must meet both Eligibility and Program Terms and Conditions.

1. Complete the entire Solar Screen or Film Residential Rebate application.
 - Option 1: Complete the application online. We suggest using this method to receive automatic updates.
 - Option 2: Deliver the application and supporting documents to 1425 Robinhood Drive. Automatic updates are not available. Please keep a copy for your records.
2. Provide a copy of the proof of purchase/ receipt itemizing the total area of equipment installed, product identifiers, performance rating specifications, and or data on the reflectivity of the window tint.
3. Provide pictures of the window with solar screen/ film.
